 - Resource Allocation Formula (RAF) discussion on the district email list (DL): These are the important issues that tend to be ignored. We need to do so much more education among adjuncts, within the unions, and to our contract colleagues.

 - 1. Tips for Adjuncts/Adjunct Survival Guide: done for Mesa but delayed publicized it because we've been spamming the DLs about contract and RAF issues. Will use it as a model for other campus reps to take on.

V. Committee Reports

- a. Adjunct Advocacy Committee- David
 - Meetings with AFT PT Caucus at AFT Guild offices. Topics for SDCCD included:
 - a. Job Security: Priority of Assignment POA under the new ratified contract

How will people like Salvador be effected? How will the provision that prevents Deans and Chairs from discouraging adjuncts to apply be enforced?

Will set up a meeting with Mahler to explain the details after Jan 11.

- b. Inter-District Health Benefits for Part-time Faculty in SDCCD and GCCCD (Los Rios/Sierra College model) Jim Mahler said he would work on it at the state level, but this should be explored.
- c. PT Parity: The proposed SDCCD and GCCCD RAF doesn't change parity, it doesn't make it worse, but it doesn't make it

better. We need to keep pushing for economic justice when determining the annual RAF calculations.

- d. Pay for Committee Work Extended Service Units (ESU): SDCCD: We got nothing. GCCCD: got it through the academic senate.
- e. Office Hours: getting something \$25-30?, but still over 50% underfunded.
- f. "Equity Hour" plan as modeled by Contra Costa District: unlikely
- g. GCCCD: Compensation for chairs is based on PT head-count which incentivizes hiring more PTers with smaller loads. Need to change the CBA to be like the SDCCD which is based on sections not heads.
